## NorKapital, Norway selects AdvisorCube and TransactionCube technology.

**NorKapital**, has a long history in Norway. Started as “Norsk Privatøkonomi” early 2000, it was acquired by Glitnir Bank and become Glitnir Privatøkonomi. After Glitnir bankruptcy the management started the new company in September/October.

At present NorKapital have 30 advisors in 7 offices in Norway, and plan to be the number one Financial Advisor group of 300 advisors in Norway in 2010.

“As a technology provider this is an interesting project as we will be a close part of the buildup of a new business including technology and consultancy. Design management routines, client reporting and follow up routines and effective client communication forum” Lasse Meholm said.

NorKapital will use AdvisorCube for CRM, Client reporting, WEB based log on and MiFID compliance. They will use TransactionCube for buy and sell of mutual fund and investment products. They are extremely focused on low cost and high quality, using the latest technology.
